### We Thank Local Foundations for Their Generous Support



We acknowledge with gratitude a generous \$15,000 grant from The R. C. Durr Foundation, Inc. the Carol Ann and Ralph V. Haile, Jr. Foundation, for the purpose of operational expenses during 2023, received in November 2022. We also acknowledge with gratitude another \$10,000 grant received from the R. C. Durr Foundation on October 31st. The purpose of the R. C. Durr grant is to support four or five students from Northern Kentucky to participate in

hands-on experience and research in Wood Hudson's Undergraduate Research Education Program in 2023. Also on October 31st, we received a \$100,000 grant from the Team Kentucky Nonprofit Assistance Fund. This grant was awarded to Wood Hudson to mitigate the loss of income in 2021 compared to 2020, as a result of the COVID-19 pandemic. We thank both the Governor and the General Assembly for supporting the inclusion of this funding in the state budget, and the Public Protection Cabinet for administering the funds. Prior to October, other grants were received to support research and education during 2022. These grants included those from the Josephine Schell Russell Trust, \$33,000, the Chemed Corporation Foundation, \$25,000, two \$10,000 grants from the R. C. Durr Foundation—one to support students in UREP, and one to support the reopening of the laboratory facilities, and the I Have Wings Foundation gave \$5,000 to support breast cancer research during 2022.

### **Research and Student Updates**

This fall, Wood Hudson Students worked with Dr. Erik Bey to learn sterile tissue culture technique. The students each learned the principles behind using a BSL2 hood for tissue culture. They each had their own set of MCF-7 breast cancer cells and performed a variety of experiments including cell growth assays in 24 well plates, and colony forming assays in p60 dishes. The students were able to accomplish performing tissue culture without major contamination issues. Students were also able to gain experience performing the Western Blot technique. In these experiments samples of MCF-7 breast cancer cells which had been treated with ARQ-761 (AKA beta-lapachone) were electrophoresed and then transblotted onto an immobilized PVDF membrane. This membrane was then probed with primary antibodies (NQO1, Actin, PARP and p53) and the appropriate secondary antibodies as well. The results of these western-blotting procedures were visualized using the Wood Hudson C-digit imaging device.



### **UREP Students Working with Dr. Bey**



My name is Men Tran (Mia) and I come from Vietnam. I'm a junior at Northern Kentucky University pursuing a Bachelor of Science with a focus on Cellular/ Molecules/ Genetics. I have been in the U.S. for almost three years. During the last few years at NKU, I took Microbiology, Genetics, Ecology, Organic Chemistry, Biochemistry, Physics, and many other science classes. I have been involved in research since my sophomore year and have always sought out research opportunities as much as possible. I have been passionate about sciences and research since I was younger, and this opportunity at Wood Hudson Cancer Research Laboratory is a great experience to prepare me for my future path.

Men Tran is one of the three students learning tissue culture techniques with Dr. Bey, and is assisting with his breast cancer study. Another student (not pictured), Fatimetov Ahmed, a junior at Northern Kentucky University, is also assisting with this project.



My name is Shakyrah Smith, I am a 2018 graduate of Taylor High School in Cleves, Ohio. I am currently a senior at Mount St. Joseph University. I will be graduating December 10<sup>th</sup>, 2022, with my B.S. in Biomedical Sciences. I joined Wood Hudson Cancer Research Laboratory on October 3rd, 2022. I applied with the hopes to gain additional medical research experience and my expectations were greatly exceeded. I have learned so much ranging from the importance of sterile technique for cell culture maintenance, and how breast cancer cells divide (cell growth and colony forming assays), respond to chemotherapy (apoptosis assays), and act in the human body (from assigned reading materials in Principles of Cancer Biology). After graduation this December, I plan to continue doing biomedical research and then apply to a physician assistant program in April of 2023. I have also been an active-duty member of the Ohio Army National Guard since I was 17 years old.

### Meet Other UREP Students at Wood Hudson

My name is Cecelia Reaugh. I am a first-year freshman at Northern Kentucky University and I work with Dr. Carter at Wood Hudson Cancer Research Laboratory. I grew up in Louisville, Kentucky, and have always had a love for biology. I am currently pursuing a degree in the Department of Biological Sciences at NKU. I was informed by a member of the Pre-Med Honors college that there was an opportunity to work with cancer research. I have a personal relationship with cancer as my mother has developed it many times, so I applied. I love working here with Dr. Carter. We stain slides of breast tissue so that we can better observe cancer under a microscope and diagnose the malignant tumors under various categories such as Infiltrating Carcinoma, Ductal Carcinoma in situ, and so on. I have learned a lot about how both research and laboratories work and I am very thankful for this opportunity and everything it has brought me. I hope to continue working here next semester as well.



Cecelia has been working with Dr. Larry Douglass and Dr. Julia Carter with microscopy on Zoom, studying immunohistochemically stained archived breast cancer surgical specimens for expression of PSPH (phosphoserine phosphatase), an important enzyme for the synthesis of the amino acid serine. Serine synthesis may be important in breast cancer development and growth, and a target for therapy.

Kimberly Holland (pictured left), a senior at Mount St. Joseph University, is preparing a poster and writing a paper for her senior capstone project that she began at Wood Hudson Cancer Research Laboratory in January, and will present to the Mt. St. Joseph Faculty in May 2023.

## Kentucky Academy of Science Annual Meeting



The Kentucky Academy of Science Annual meeting was held on November 11th and 12th this year, hosted by Morehead State University. Approximately 700 scientists and students attended this joint meeting of the Kentucky Academy of Science and the Kentucky Junior Academy of Science. Morehead State University is at the forefront of STEM education in the Commonwealth of Kentucky, and is the home of the Craft Academy for Excellence in Science and Mathematics. The Craft Academy is a dual-credit academy for academically exceptional Kentucky students interested in pursuing STEM degrees. On Saturday, November 12th, Dr. Jay Morgan, President of Morehead

State University, welcomed the scientists before the plenary session entitled "Traveling Through Disciplines" with keynote speaker Dr. Andrea Armani. Oral presentations and posters were given by undergraduate students and high school students in 14 different disciplines. For the first time since the Academy's founding in 1914, a session was held focused on cancer. Dr. Julia Carter,

President of Wood Hudson Cancer Research Laboratory, and Courtney Martin, a graduate student at the University of Kentucky, co-chaired this session on cancer. Six high school and undergraduate students presented research reports, and Dr. Erik Bey, senior staff scientist at Wood Hudson, presented a report on his research and plans for the Undergraduate Research Education Program (UREP). High school students gave reports on innovative projects, such as "Developing a Low-Cost Device for the Diagnosis of Thyroid Cancer". College undergraduates from Northern Kentucky University, Berea College, Western Kentucky University, and Wood Hudson Cancer Research Lab gave presentations on genetic molecular changes in cancer. One of the student reports was by Jonathan Scherff (pictured), a Wood Hudson UREP student and sophomore at Mt. St. Joseph University. Jonathan's presentation reported the research proposal he prepared while participating in the summer virtual UREP held by Wood Hudson. Jonathan writes, "I want to thank Dr. Carter for giving me the opportunity to present my research project at KAS. I also want to especially thank Dr. Bey, Dr. Douglass, Dr. Snyder, Professor Gilb, and the rest of the Wood Hudson team for their support and guidance over the last 5 months. 





### **End-of-Year Giving**



<u>A Gift of Stock — Provides Tax Advantages:</u> A gift of appreciated stocks or mutual fund shares to Wood Hudson can provide you with the best tax advantages. You will get a charitable deduction for the full amount of the gift, just as you would if your gift was made with cash, and you don't incur capital gains tax on the appreciation. If you can't use all of the income tax charitable deduction resulting from the gift, you can carry it forward for up to 5 years!

<u>How to Transfer a Gift of Stock:</u> Gifts of stock or mutual fund shares can be given to benefit Wood Hudson. The proceeds can be directed to the Lab or designated to a program at the Lab such as our Undergraduate Research Education Program (UREP). For transfer instructions, please contact the Lab at (859) 581-7249.

**Donating IRA Assets to Charity:** Turn your Required Minimum Distribution (RMD) into charitable donations. If you are 70 1/2 or older, you can donate up to \$100,000 tax free from your IRA each year to Wood Hudson. Your distribution will not be included in your income if it is sent directly to Wood Hudson.

<u>Utilizing a Charitable Trust:</u> A charitable trust allows you to donate cash or assets to Wood Hudson and obtain a current tax deduction even though the cash or assets are not actually transferred to Wood Hudson until some time in the future. There are basically two types of trusts – a **Charitable Lead Trust (CLT)** and a **Charitable Remainder Trust (CRT)**.

A CLT is an irrevocable trust that is established to distribute an income stream to Wood Hudson for a set number of years. Upon the expiration of the trust, the assets that remain in the trust revert back to you, your heirs, or other designated beneficiaries.

A CRT works a bit differently than a CLT. A CRT is an irrevocable trust that provides you with a stream of income for your life or set period of years with the assets remaining in the trust going to Wood Hudson upon your death or the expiration of the trust period.

Which trust you decide upon, and the terms of the trust should be based upon your specific situation and what goals you have in mind. Establishing a charitable trust can be a rewarding way to make an impact for a cause you care about deeply while still retaining the benefits of a stream of income, current deductions for gift and estate taxes, and a current year income tax deduction when the trust is established.
